§ 1

§ 2

In the semester, in which the housing period commences, SGH Warsaw School of  
Economics shall provide a place in the room no. .... at the Student Residence Hall  
no. .... at ul. .... in Warsaw, along with the  
appliances described in the annex to the Agreement. In the following semester (if the  
Agreement was concluded for the whole academic year), at the request of the  
Students' Union Residence Halls Committee/Doctoral Student Grants Appeals  
Committee\*, a student/doctoral student\* may be assigned a place in another room.

### § 3

1. The semester housing fee shall be charged in compliance with the provisions of the Rules and Regulations of SGH Warsaw School of Economics Student Residence Hall and shall amount to PLN ..... /semester (in words: .....).
2. The fee may be paid for the whole semester or in partial instalments. The fee must be paid to the bank account visible in the USOSweb system. The payment obligation shall be regarded as fulfilled only when the amount due has been booked to the account indicated in the USOSweb system by the last day of the payment period.
3. In order to secure the University's claims towards the student/doctoral student\* hereunder, and in particular, in order to secure rent payments, the student/doctoral student\* shall pay a deposit of PLN ..... (in words: .....).
4. The deposit shall be also used to account for other liabilities the student/doctoral student\* may have towards the University – pursuant to the provisions stipulated in the Rules and Regulations of SGH Warsaw School of Economics Student Residence Hall.

### § 4

The student/doctoral student\* declares that he or she has read the contents of: the Rules and Regulations of SGH Warsaw School of Economics Student Residence Hall, occupational safety and health and fire safety regulations, and undertakes to adhere thereto. The aforementioned documents are also made publicly available in the administration unit of the Student Residence Hall and posted on the websites of the University's units.

### § 5

The Agreement is terminated as a result of the lapse of the time period for which it has been concluded and also in the following cases:

- 1) termination hereof in compliance with the provisions of the Rules and Regulations of SGH Warsaw School of Economics Student Residence Hall;
- 2) the referral's validity has expired in cases specified in the Rules and Regulations of SGH Warsaw School of Economics Student Residence Hall.

§ 6

1. The Agreement has been drawn up in two counterparts, with one copy for each Party.
2. Any amendments hereto must be made in writing or else shall be null and void.
